Strategic Review of Implementation of Youth Vision 2025

1. British Council

The British Council is the UK's international organisation for cultural relations and educational opportunities. 2. National Youth Council

National Youth Council is the central government agency established by the Government of Nepal through National Youth Council Act 2072 (2015) for development and mobilization of youth in Nepal.

The council implements and facilitates youth-focused plans and programs outlined in National Youth Policy 2072 and Youth Vision 2025. The council also coordinates and facilitate youth programs at federal, provincial, district and local levels. Additionally, the National Youth Council also collaborates for youth-focused run by other governments and non-government organizations.

3. Background

In response to the pressing challenges faced by Nepalese youth, the Government of Nepal, through the Ministry of Youth and Sports (MoYS), introduced the "Youth Vision 2025", a tenyear strategic plan introduced in 2015 with the aim of holistic youth development. This plan is aligned with the National Youth Policy-2015. The policy defines individuals aged 16 to 40 as youth in Nepal representing upwards of 40% of Nepal's total population¹.

The "Youth Vision 2025" framework emphasizes unity, equity, justice, harmony, and inclusion as foundational principles for empowering the younger generation. It underscores the necessity of investing in youth to drive the nation's economic progress. This vision aligns with Nepal's broader national policies and international frameworks like the United Nations Sustainable

Development Goals (SDGs). The strategy was developed in response to key challenges faced by youth, such as unemployment, limited access to quality education, lack of entrepreneurial opportunities, and inadequate representation in leadership roles².

The strategic plan focuses on the following key pillars of youth development:

- 1. **Quality and Vocational Education**: Enhancing access to quality education and vocational training.
- 2. **Employment, Entrepreneurship and Skill Development**: Creating job opportunities and fostering entrepreneurial skills.
- 3. **Health and Social Security**: Ensuring equitable access to healthcare services and social protection.
- 4. **Mobilization, Participation and Leadership Development**: Cultivating leadership qualities and encouraging active civic participation.
- 5. **Sports and Entertainment**: Promoting physical well-being and recreational activities and advance national sports to become competitive internationally.

Implementation of the "Youth Vision 2025" is facilitated through the National Youth Council (NYC), established through 'Youth Council Act 2015'. NYC works to ensure a coordinated approach across various sectors towards the 5 key pillars of youth development. Special emphasis is placed on marginalized communities, aiming to provide them with recognition and tailored programs to bridge existing disparities.

The strategic plan was envisioned at the time, to address challenges arising from significant events, such as the 2015 earthquakes, by involving youth in reconstruction and nation-building efforts. Collaborative initiatives between the government, CSOs and youth organizations have been pivotal in promoting youth leadership and participation in these processes.

However, over the past decade, young people's concerns in Nepal have evolved. Youth perception see employment and poverty as two primary issues of concern, closely followed by climate change³. Young people find their needs and aspirations unmatched by opportunities domestically. About 550,00 young people enter the labour market annually, a significant number seeking opportunities abroad. Data released from Department of Foreign Employment (DoFE) states that over 741,000 Nepali left for foreign employment just in the fiscal year of 2023/24 ⁴. Integration of young people into development process also remains a challenge. They lack political representation and institutions that harnesses their capacity for leadership. They are becoming increasingly disillusioned with political and economic systems that fail to adequately

prioritize environmental concerns, especially as climate change poses a growing threat to countries like Nepal.

As the "Youth Vision 2025" approaches its culmination, a comprehensive strategic review is now imperative to assess its impact, identify successes and challenges, and inform future strategies for sustained youth development in Nepal.

The British Council and the National Youth Council have signed a Memorandum of Understanding to advance the common goal of youth development in the country. This collaboration provides a framework for joint efforts to support youth development through capacity-building programs, policy dialogues, and social action projects. It aims to empower young people to influence their future and address key social challenges. The partnership fosters connections between UK and Nepal institutions while enhancing opportunities for young leaders and policymakers. Additionally, it includes technical assistance and other mutually agreed activities and strategic alliances, to strengthen youth engagement and social cohesion for youth development in Nepal.

One of the areas identified under the partnership is British Council supporting NYC in conducting a strategic review of Youth Vision 2025. This strategic review will play a pivotal role in shaping Nepal's next phase of youth development strategies, ensuring they align with the current realities and aspirations of Nepali youth.

4. Objective

The objectives of the review are to

- Assess relevancy and alignment of the strategy with relevant national and international policies and frameworks, Nepal's contemporary social, political, and economic situation, and emerging challenges affecting youths.
- Assess the implementation of programs under 'Youth Vision 2025'.
- Highlight success, challenges, and gaps in the strategy.
- Provide strategic recommendations for improvement in the strategy beyond 2025.

5. Scope of Work

The consultant will align their work with the objectives, and carryout the following work.

- Assess existing reports and documents from the National Youth Council.
- Desk Review existing literature, policies, and other related documents related to status of youth and youth development in Nepal. This includes analysis of relevant assessments/reports on 'Youth Vision 2025' from independent bodies, CSOs, think tanks, media houses and other institutions over the 10 years of implementation of the strategy.

- Coordinate with working group formed with members of MoYS and NYC.
- Consult stakeholders including government agencies, CSOs and youth organizations, program beneficiaries, from all 7 provinces, through planned consultation events (Face to Face/ Online).
- Prepare a detailed report with key findings and strategic recommendations for youth development for the next 10 years.

6. Methodology

- Desk Review: of relevant policies and reports.
- Key Informant Interviews: with policymakers, implementers, CSOs, youth groups and youth leaders.
- Focus Group Discussions: with government officials, youth beneficiaries, CSOs, youth groups and youth leaders.
- Case studies: of best practices and success stories from within and outside of the strategy.
